- ▶ 94 U.S. marshals, one for each federal court district
- ▶ 3,858 deputy U.S. marshals and criminal investigators
- ▶ 1,746 administrative employees and detention enforcement officers
- ▶ 5,604 total employees (does not include the 73 Presidentially appointed U.S. Marshals)
- ▶ 94 districts, 218 sub-offices, four foreign field offices

- ▶ FY 2023: \$1.705 billion (salaries and expenses)
